#### 1. Introduction:

KOMAK (KDAO) is an Afghan humanitarian relief and development non-governmental organization established in 2018 under registration number 4506 with Ministry of Economy Afghanistan with the objectives of providing relief and emergency services, and long-term sustainable development projects. KOMAK (KDAO) is working in many provinces throughout Afghanistan carrying out short and long-term projects in emergency relief, Health, WASH, Education, Protection, shelter, safe drinking water to the people of Afghanistan.

KOMAK (KDAO) means caretaker aimed at backing the weaker section of the society. We are committed to improve the educational, health, social and psychosocial, WASH, Shelter, Refugee, Returnee and IDPs support, Agricultures, Livelihoods, Helping orphans, community awareness, women and youth support, water and environmental sanitation, and other emergency and post emergency programs in Afghanistan.

Dedicated to tackling the root causes of poverty in the country, KOMAK (KDAO) is passionate about working beyond the provision of immediate relief, towards supporting communities over the long-term. In short, KOMAK (KDAO) plays the role of curing the weaker section of the community from their affected injuries. Having presence all over the country, we are able to distribute aid and provide services in an effective, efficient, transparent, and accountable manner and to make a lasting difference and impact to the communities we work with.

KOMAK (KDAO) is blessed with a large group of members, the members include medical professionals, Program and operation experts, and other professionals in the non-profit sector. KOMAK (KDAO) works under the effective management of the Board of Directors. There are 5 directors on the board and the BoD meets once every quarter and holds one annual meeting. The board reviews the activities and progress of the year, and it also plans the next year's activities. The annual activities of KOMAK (KDAO) starts on March 21st with the start of Hijri Shamsi Calendar.

It is headquartered in Kabul and is currently working in Kabul and other provinces for the last 5 years. KOMAK (KDAO) has developed its thematic expertise and the capacity of its staff in correspondence with the evolving needs of the country. KOMAK (KDAO) targets the most vulnerable in its interventions, including children, women, internally displaced persons (IDPs), and returnee refugees, as well as the most impoverished and marginalized families. These priorities have been chosen to contribute to our Goal of, "Improved survival and well-being of Afghan girls and boys, building the foundations for a better future for Afghan children and their communities."



#### 2. Vision:

The KOMAK (KDAO) vision is to provide relief, rebuild communities and enable self-reliance. We are working towards tackling the root causes of poverty and create a better community for the people of Afghanistan. KOMAK (KDAO) believes that every Afghan has the right to health care, education, food, clean water, and the means to support themselves, their families, and their society. KOMAK (KDAO) strives to empower people for the long-term, rather than just providing immediate relief.

#### **Our Staff**

#### Staff capacity building

KOMAK (KDAO) believes that the progress made is directly proportional to its resources specially, people, so its development will directly come the way its resource people are. Since the staff is the most important resource the organization has, it has given a special consideration and in the plan staff is always provided capacity building trainings, workshops, seminars, and on-job trainings both in person and online every year.

#### Our financial management

Financial management practice is a very crucial objective for any organization to attain development programs of the organization. The financial activities of the organization are entirely based on the budget approved by the technical support team which is intended to run the activities. The accounting system of the Organization is based on the general accepted accounting principles GAAP.

All materials and services that the project needs will be budgeted, and it's the duty of the accountant to release the budget line items and to control invoices and other supported documents before respective section prepares the payment. Invoice, contract payroll, etc. should be attached to the payment voucher to back up and confirm the payment.

The authorized limit is one of the major components of internal control system of the organization and the authority limit in the KOMAK (KDAO) policy and authorization matrix is clearly defined. So as to enforce that policy, each relevant project have been given the defined authority to approve the limited amount. If the payment exceeds the limited amount no payment will be made without the approval of either one or two senior staff of the organization.

KOMAK (KDAO) has the policy of maintaining petty cash fund to cover small payments of the office requirements. The amount are located to use for petty cash fund is clearly defined in the policy and it should be released in reimbursement system the cashier is responsible for receiving holding and disbursing, the petty cash fund and to keep relevant accounting records.

KOMAK (KDAO)'s procurement policy also defines the different procurement procedures in order to meet the requirements of the organization as well as to facilitate the needs of the organization and maintain transparency and accountability.


- 1. To safeguard the general interest of our members and the organization goal.
